2 GENERELT

All prices are given in Norwegian Krone (NOK) VAT/MVA not included. For further information relating to business practices and the prices shown, refer to the Terms and Conditions for Port of Hammerfest KF (Hammerfest Havn KF).

The operator or representative of any vessel shall give suitable notice to the Port Authority before the vessel's arrival in the Port District (If possible, at least 24 hours before arrival). Advanced notice can be given preferably to Safe Sea Net or via email: havnevakt@hammerfest.havn.no

Any changes or cancellations are to be communicated using the same methods.

Should any changes to time of arrival/departure happen in under 24 hours of the agreed times, additional charges will apply to compensate for any resulting extra costs.

The general increase in costs due to interest and the rise in prices is used as the basis for the increase in prices in 2024.

A change has been made when it comes to renovation. This is now included in the quay charges.



In order to reduce paper consumption and save the environment, Hammerfest Havn KF charges an invoice fee of NOK 100.00 ex VAT on all invoices sent by post. 3 FAIRWAY DUES AND QUAY CHARGES

FAIRWAYS CHARGE

Fairways charge accrues per call in the designated area. Repeat calls within the same 24 hour period will result in only one additional charge.

For vessels that call at the port regularly, the Port Authority can decide to charge for a fixed amount of calls within a calendar month. A monthly fee can also be established.

Vessels that mainly dock without leaving the rentable area pay for their usage of the fairway and harbour. Charges can be calculated on a monthly or annual basis & it should be clearly disclosed if vessels are to be stationary or active.

QUAY CHARGE

The Quay Charge is the ships payment for the use of Quays either leased by Port of Hammerfest KF, or those that are part-owned by Port of Hammerfest KF. The Quay charge is comprised of two elements: payment for each time a ship docks and payment for the duration of a ships' stay at the quay. Pricing policy is based on gross tonnage, which is in accordance with established practices. The Quay charge does not cover eventual use of the Quay area.

- Ships with an ESI score above 50 receive a 20% discount.
- Ships with an ESI score above 70 receive a 40% discount.

The ISPS charge is set at 30% of the quay charge per 24 hours. There will be additional costs to cover Security.

Under the normal working circumstances of Security Level 1, charges are as shown in the price list. Should the security level escalate, vessels will be required to pay additional costs that are incurred as a result.

3.4.1 ENVIROMENTAL PORT INDEX (EPI)



Environmental Port Index (EPI) is a model for quantifying and reporting cruise ships' environmental impact during port stays. The aim is for this to provide incentives within green technological solutions, as well as increase port costs for the most polluting vessels.

Cruise ships arriving at Hammerfest Harbor must report data from the call no later than 72 hours after departure. The EPI score will give a discount/addition in the quay fee based on this table.

In the event of cancellation less than 48 hours before the scheduled call, the actual incurred costs and 20% of the quay fee will be invoiced.

- For mooring services between 15:30 and 08:00, as well as weekends and public holidays, the rates are increased NOK. 2 012,00 per worker.
- Agreements with suppliers can be established outside made outside the regulation rates.
- Transport NOK 216,00 is added to the fee.
